SUSQUEHANNA RIVER RAIL BRIDGE PROJECT



Project Kick-Off

On July 19, 2024, Amtrak joined the U.S. Department of Transportation (USDOT), the Federal Administration (FRA), the Maryland Department of Transportation (MDOT), the Maryland Transit Administration (MTA), and state and local elected officials to formally kick-off the Susquehanna River Rail Bridge Project. Pre-construction work, including the removal of the 1866 remnant piers is now underway. This critical infrastructure project will support continued connectivity along the Northeast Corridor (NEC), America's busiest passenger rail corridor, and will advance Amtrak's new era of rail. This early work will support the start of bridge construction anticipated to begin next year. The \$2.7B Project is funded by the Bipartisan Infrastructure Law. thanks to a \$2.08B Fed-State NEC grant announced by FRA in late 2023. Click here to read more about the event.

Frequently Asked Questions

• How will the new bridges benefit boating and navigation in the Susquehanna River?

A The project will improve navigation along the Susquehanna River by increasing both vertical and horizontal clearance. The design of the new bridges will provide 60 feet of fixed vertical clearance and 235 feet of horizontal clearance.

Pre-construction Activities

Amtrak and its contractors began the removal of the 1866 remnant piers in June 2024. As of the end of August 2024, six of the ten piers have been substantially removed from the Susquehanna River. All of the piers are anticipated to be removed by the end of November 2024. Concurrent with the remnant pier removal, Amtrak's contractors are making necessary interim repairs to the existing Susquehanna River Rail Bridge. In preparation for bridge construction, the Project team is also conducting environmental surveys to better understand subsurface conditions. The team will be in various locations throughout the Project area to collect soil and in-river water samples. All disturbed areas will be restored upon completion of the surveys. Digging Through History

As part of the environmental review process, Amtrak completed archaeological studies in 2014 using documentary sources to identify areas with potential for archaeological deposits. In August 2024, Amtrak and its contractors conducted supplemental archaeological surveys in Havre de Grace and Perryville to further investigate the archeological context and sensitivity at potential sites within the project area. The team completed digs in thirteen locations and are preparing technical reports that will be reviewed by the Maryland Historical Trust. Should items of interest be found, Amtrak will adhere to procedures outlined in the **Programmatic Agreement**.

Get Involved

As part of the environmental permitting process, Amtrak will be hosting a public hearing in partnership with the Maryland Department of the Environment. The hearing will take place at 6:00 PM on September 19, 2024, at the Havre de Grace Activity Center. A poster session will take place from 6:00 to 6:30 PM followed by a public hearing in accordance with the Joint Permit Application regulations. Public comments will be accepted during the hearing.
